#### COMPANY LIMITED BY SHARES

- 1<sup>st</sup> The name of the company is **3C IT SOLUTIONS & TELECOMS (INDIA) LIMITED**\*
- 2<sup>nd</sup> The Registered Office of the Company will be situated in State of Maharashtra within the jurisdiction of Registrar of Companies, Pune.
- 3<sup>rd</sup> The objects to be pursued by the company on its incorporation are:-

# (a) THE MAIN OBJECT OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION IS:

 To carry in India or elsewhere the Business of writing, creating, assembling modifying, updating, upgrading programming systems, telecommunication systems, providing services such as software and Hardware development services, upgradation, updation, solution, web creation and developing services and to act as consultants in Information Technology Services, Telecommunication Services, Computer Programming Services and such all other ancillary services relating to software, hardware, telecommunication and Information technology.

## (b) MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECT SPECIFIED IN CLAUSE 3 (a) ARE:-

2. To establish, equip, and maintain software development centers, workshops, offices, branches for carrying on the business of the Company and to do all other things necessary to be done in that behalf and to do all experimental and research and other developmental work in connection with any of the softwares and services intended to be provided by the Company.

- 3. To provide and deal in India or elsewhere hardware, e-commerece solutions, security solutions, virtual private network, network and network enabled services, Internet Service Providers (ISP), Intranet Solutions, EDI solution, leased line solutions, hosting, warehousing, storing, forwarding, and on line information services, and to develop, host design and develop, maintain, create, program, service all types of websites, portals, and to provide facilities of advertising and publishing on the web and to provide consultancy in the field of software, internet, e-commerce and to provide services in the field of netbanking, internet backbone services, on line data management, supply chain management consultancy, web strategy development, multimedia and digital video broad band communication, system integration, digital signature solutions and certification and to do all web based activities and business.
- 4. To pay for any property, rights or privileges, acquired by the Company or for the services rendered or to be rendered in connection with the promotion of or the business of the Company or for acquisition of any property for the company or otherwise either wholly or partially in cash or in shares, bonds, debentures or other securities of the company and to issue any shares either as fully paid up or with such amount credited as paid up thereon, as may be agreed upon and to charge any such bonds, debentures or other securities upon all or any part of the property of the company. While so doing the company shall comply with all requirements of law for the time being in force.
- 5. To sell, exchange, mortgage, let on lease, royalty or tribute, grant licences, easements, options and other rights over and in any other manner deal with or dispose of the whole or any part of the undertaking, property, assets, rights and effects of the company for such consideration as may be thought fit and in particular for stock, shares, whether fully or partly paid up, or securities of any other company.
- 6. To arrange, manage, promote, motivate, subsidise, and organize training programmes, for any member or any of the Company's employees or directors or any other candidate at all levels as may be conducive to the interest of the company and for that purpose establish and set-up training centres, laboratories, equipments and instruments and hold seminars, conferences, work shops, study meetings, group discussions, and other devices in India or elsewhere in the world and for the purpose incur recurring and non-recurring expenses, grant stipends, scholarships etc. as may be necessary from time to time.
- 7. To acquire, purchase, takeover, manage and undertake the whole or any part of the business, property and liabilities of any person, firm or body corporate carrying on or proposing to carry on any business which the Company is authorised to carry on or possessed of property suitable for the purposes of the Company, or which can be carried on in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the Company
- 8. .To improve, manage, cultivate, develop, exchange, let on lease, mortgage, sell, dispose of, turn to account, grants rights and privileges in respect of or deal with all or any of the properties and rights of the company on such terms as the Company shall determine, and to supply power, light and heat, to lay out land for building purposes, and to sell the same, and to build on, improve, let on building leases, advances money to persons, building or otherwise to develop the same.

- 9. To establish, develop and maintain and aid in the establishment, development and maintenance of laboratories, research stations and programmes, softwares for the purpose of effecting improvement of any of the activity of the Company.
- 10. To act as consultants and to give expert technical, financial and managerial advice to industries, institutions, and business organizations, customers engaged in similar industries, trade and commerce and for the purpose of the business to promote, counsel and finance industries and protect and promote their interest.
- 11. To enter into contracts, agreements and arrangement with any other company body or individual for carrying out on behalf of the company of any of the objects for which the company is formed.
- 12. To design, implement, install, and maintain the management information systems of various organizations using the computer softwares and hardware.
- 13. To carry on the activity of marketing, launching, developing and distributing of products of any company or organization and to act as marketing consultants, agents and distributors for any company or organization in India or elsewhere in the world.
- 14. To invent, apply, utilise, implement, establish, marketing techniques, and methods and ways and means to market, distribute, supply, advertise, popularise, sale, circulate any product by the Company
- 15. To establish, maintain, and run franchise, outlets, associate network, distribution, and collection centers, shops and depots and to act as consultant, franchise, associates, authorised representative, agents, distributors, marketers for various schemes, introduced by the Company for marketing, selling, distributing, supplying various products of the Company or other companies or persons or bodies.
- 16. To arrange, organise or to do all the work for arranging fairs, exhibitions, for the purpose of advertisement and pursing the main objects of the Company.
- 17. To arrange or publish such material of literature, brochures, advertisement through various media of communication including cables, internet, television, as is required for the purpose of the main objects of the Company and for advertisement of the business of the Company.
- 18. To insure the whole or any part of the property of the Company to protect the same from any loss.
- 19. To sublet contract from time to time and upon such terms and conditions as may be thought expedient.
- 20. To supply to industries, trade and commerce or other institutions and customers, technical know-how, technical guidance and technically trained personnel in relation to the aforesaid products for the development of such industries for cash or any other consideration or for the lease, hire, royalty or other compensation or on hire purchase system or otherwise.
- 21. To carry on search, research, scientific experiments, investigations, testing and work so as to develop products or process or improve the quality or reduce the

cost and/or to pay contribute or to do all such acts and things for the purpose of securing any process, patent or invention which the company may acquire or propose to acquire or deal with.

- 22. To apply for, purchase or acquire and obtain any patents, brevets invention, licenses, permissions, concessions, processes and the like conferring any exclusive or limited right either in point of times or otherwise to use the same, or any secret or other information as to any invention which may seem capable of being used for any purpose of the Company and to use, exercise, develop or grant licenses, in respect of or otherwise turn to account any patents, inventions, licenses, permissions, concessions, processes and the like, and the information so required.
- 23. To enter into partnership or into any arrangements for sharing profits, union of interests, cooperation, joint venture, reciprocal concession or otherwise with any person, firm, company or bodies corporate carrying on or engaged in or about to carry on or engage in any business or transaction which this Company is authorised to carry on.
- 24. To sell or dispose any of the undertaking of the Company or any part thereof for such consideration as the Company may think fit, and in particular for shares, debentures or securities of any other Company.
- 25. To guarantee the payment or performance of any debts, contracts or obligations or give security for any person, firm or company for any purpose whatsoever.
- 26. To subscribe or contribute or to assist charitable, benevolent, religious, scientific, national, public, political or any other institutions, objects or purposes or any exhibition.
- 27. Subject to approval of appropriate authority to undertake and execute any trusts the undertaking of which may seem to the company desirable and either gratuitous or otherwise for the purpose of main objects of the Company.
- 28. To make advances of such sum or sums of money, upon or in respect of or for the purchases of raw materials, goods, machinery, stores, or any property, articles and things required for the purposes of the company upon such terms with or without security as the Company may deem expedient.
- 29. To sell, improve, manage, develop, exchange, lease, mortgage, enfranchise, dispose of, turn to account or otherwise deal with all or any part of the property and rights of the Company.
- 30. To borrow or raise or secure the payment of money or to receive money on deposit other than public deposit at interest for any of the purposes of the Company and at such time or times and in such manner as may be thought fit and in particular by the issue of debentures or debenture-stock perpetual or otherwise, including debentures or debenture-stock convertible into shares of this or any other Company, or perpetual annuities and for security for any such money so borrowed, raised or received, or of any such debentures or debenture-stock so issued to mortgage, pledge or charge the whole or any part of the property, assets, or revenue and profits of the Company present or future including its uncalled capital by special assignment or otherwise or to transfer or convey the same absolutely or in trust, and to give the lenders power of sale and

other powers as may seem expedient, and to purchase, redeem or pay off any such securities.

- 31. To open an account or accounts with any Bank or Bankers and to pay in to and withdraw money from such account or accounts.
- 32. To remunerate any person or Company for services rendered or to be rendered in placing or assisting to place or guaranteeing the placing of any shares in the Company's capital or any debentures, debenture-stock or other securities of the Company or the conduct of its business.
- 33. To remunerate any person, firm or Company rendering services to this Company, either by cash payment or by the allotment to him or them of shares or securities of the Company credited as paid up to in full or in part, or otherwise as may be thought expedient.
- 34. To pay all or any expenses incurred in connection with the promotion, formation and incorporation of the Company, or to contract with any person, firm or Company to pay the same, and to pay commissions to brokers and others for underwriting placing, selling or guaranteeing the subscription of any shares, Debentures, Debenture-stock or securities of the Company.
- 35. To indemnify, Officers, Directors, Agents, and servants of the Company against proceedings, costs damages, claims and demands in respect of anything done, or ordered to be done by them for and in the interests of the Company, or for any loss, damages, or misfortune whatever, which shall happen in execution of the duties of their office or in relation thereto.
- 36. To create any reserve fund, sinking fund, or any other special fund whether for depreciation or for repairing, improving extending or maintaining, any of the property of the Company or for purposes conducive to the interests of the Company.
